## ORDERS

Imphal, the 16<sup>th</sup> November, 2024

No.H-3607/4/2022-HD-HD(Pt) : In view of the prevailing law and order situation in the State, there is apprehension that some anti-social elements might use social media extensively for transmission of images, hate speech and hate video messages inciting the passions of the public which might have serious repercussions for the law and order situation in the State of Manipur;

2. Whereas, there is an imminent danger of loss of life and /or damage to public/private property, and wide spread disturbances to public tranquillity and communal harmony, as a result of inflammatory material and false rumours, which might be transmitted/circulated to the public through social media/messaging services on mobile services, SMS services and dongle services;

3. And whereas, to thwart the design and activities of anti-national and anti-social elements and to maintain peace and communal harmony and to prevent any loss of life or danger to public/private property, it has become necessary to take adequate measures to maintain law and order in public interest, by stopping the spread of disinformation and false rumours, through various social media platform such as Whats App, Facebook, Instagram, Twitter etc. on various electronic equipments like tablet, computer, mobile phone etc. and sending bulk SMS, for facilitating and/or mobilization of mobs of agitators and demonstrators, which can cause loss of life and/or damage to public/private property by indulging in arson/vandalism and other types of violent activities;

4. Now, therefore, in exercise of the powers conferred under Rule 2 of Temporary Suspension of Telecom Services (Public Emergency or Public Safety) Rules, 2017, having satisfied that the above situation is likely to cause serious disturbances to the peaceful co-existence and maintenance of public order, do hereby order temporary suspension/curbing of internet and mobile data services including VSATs, broadband (IILL & FTTH) and VPN services in the territorial jurisdiction of currently affected districts of Imphal West, Imphal East, Bishnupur, Thoubal, Kakching, Kangpokpi and Churachandpur of Manipur for 2 (Two) days with effect from 5:15 PM of 16-11-2024 except for those Lease lines and FTTH connections to Government Offices or any case whereby the State Government grants exemption.

5. The order is being passed ex-parte in view of the emergent situation. It shall be published for the information of public through press and electronic media.

6. Any person found guilty for violation of aforesaid orders will be liable for legal action.



Case No. 6 of 2024: Whereas, the Office of the undersigned had issued prohibitory orders under Section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023 for restriction of the movement of any person outside their respective residences w.e.f. 1<sup>st</sup> November, 2024 and until further orders;

And whereas, this office had issued order for curfew relaxation from 05:00 AM to 08:00 PM of 16<sup>th</sup> November, 2024 vide order no. Cril. Misc. Case No. 6 of 2024 dated 15<sup>th</sup> November, 2024;

Now, due to the developing law and order situation in the district, the above mentioned curfew relaxation order stands cancelled with immediate effect i.e. from 4:30 PM of 16<sup>th</sup> November, 2024. Total curfew is imposed w.e.f. from 4:30 PM of 16<sup>th</sup> November, 2024 until further orders.

All persons belonging to essential services such as Health, Electricity, CAF & PD, PHED, Petrol Pumps, Municipality, Press and Electronic media, functioning of Courts and to and fro movement of flight passengers to airport and Contractor/Worker with valid Airport Entry Permit (AEP) Card shall be exempted from the curfew.
